1. In future regarding any complaint/ inspection if found that for applying for the NOC you have given the wrong information in the application or if you have not followed the instructions issued by the Punjab Govt. time to time and you are not following the conditions written in the affidavits, in that conditions the NOC will be withdrawn.

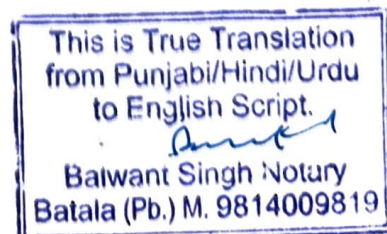
2. The teaching of Punjabi language upto Tenth (Matric) class will be made compulsory in the school and CESE, New Delhi will made proper arrangements for taking Exams of Punjabi failing which the NOC will be withdrawn.

3. The School management will abide by the rules and regulations guidelines of RTE Act. 2009 and also follow the notifications of RTE Act.2009 issued by the Education Department, Punjab.

4. After getting the affiliation from the CBSE, New Delhi the school management will be bound to give salary and other allowances equivalent to the employees of the State Govt. through account payee cheque to all its teaching and non-teaching staff. In contravention, no objection certificate will be withdrawn immediately.

5. You and your management will ensure to supply the necessary information to the District Education Officer or by any senior officer of the Education Department, as and when desired and also ensure the necessary corporation. In contravention, no objection certificate will be withdrawn immediately.

7. The school will follow all the guidelines issued by the Punjab Government vide letter No-2/93/2009/3C3/1360154 Dated 26-11-2018

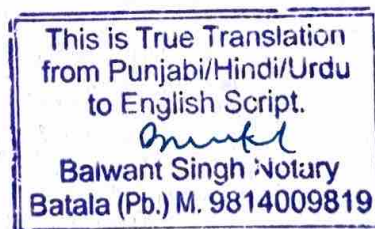
